

Submissions

- 1. By Thursday, 9 November 2023, each Applicant file and serve on the Australian Competition and Consumer Commission (ACCC) and Bendigo and Adelaide Bank Limited (BABL):
 - a. a written outline of submissions; and
 - b. a list of authorities on which they intend to rely at the hearing.
- 2. By Friday, 17 November 2023, BABL file and serve on the Applicants and the ACCC:
 - a. a written outline of submissions; and
 - b. a list of authorities on which it intends to rely at the hearing.
- 3. By Wednesday, 22 November 2023, the ACCC file and serve on the Applicants and BABL:





- b. a list of authorities on which it intends to rely at the hearing.
- 4. By Wednesday, 29 November 2023, each Applicant file and serve on the ACCC and BABL:
 - a. a written outline of submissions in reply; and
 - b. a list of authorities on which they intend to rely at the hearing.
- 5. The written outlines of submissions are subject to the following page limits:
 - a. the submissions filed in accordance with Direction 1 are to be no more than 60 pages combined;
 - b. the submissions filed in accordance with Directions 2 and 3 are to be no more than 60 pages combined, but the submissions filed by BABL in accordance with order 2 are to be no more than 30 pages;
 - c. the submissions filed in accordance with Direction 4 are to be no more than 20 pages combined.

6. Prior to the hearing, the parties file and serve an electronic joint bundle of authorities and legislation in text-recognised PDF format and which contains electronic bookmarks to each document in the bundle.

Hearing Book

- 7. The number of days for compliance with Direction 18 of the directions made by O'Bryan J dated 29 August 2023 (29 August 2023 Directions) be varied from 30 days to 35 days (Monday, 30 October 2023).
- 8. The number of days for compliance with Direction 19 of the 29 August 2023 Directions be varied from 25 days to 28 days (Monday, 6 November 2023).
